 - 5.3 Mayors Permit;
 - 5.4 Photocopy of valid PhilGEPS Certificate;
 - 5.5 Tax Clearance;
 - 5.6 Valid Philippine Contractors Accreditation Board (PCAB) license and registration for the type and cost of the contract for this Project;
 - 5.7 List of contractor's personnel (viz, Project Manager, Project Engineer, and Foreman, Skilled Workers) to be assigned to the contract to be bid;
