## REQUEST FOR QUOTATION

3. The quotation shall be quoted in Philippine Pesos, inclusive of all taxes to be paid if the contract is awarded.

5. The proposals shall contain the following:
  - 5.1 Registration certificate from the Securities and Exchange Commission (SEC), Department of Trade and Industry (DTI) for sole proprietorship, or Cooperative Development Authority (CDA) for cooperatives;
  - 5.2 Mayor's Permit;

- 5.3 Valid Philippine Contractors Accreditation Board (PCAB) license and registration for the type and cost of the contract for the projects stated above;
  - 5.4 List of all its ongoing and completed government and private contracts within ten (10) years from the submission of bids, including contracts awarded but not yet started, if any.
  - 5.5 List of contractor's personnel (Project Manager, Project Engineer, and Foreman, Skilled Workers) to be assigned to the contract to be bid;
  - 5.6 List of contractor's equipment units, which are owned, leased, and/or under purchase agreements, supported by certification of availability of equipment from the equipment lessor/vendor for the duration of the project;
  - 5.7 Construction schedule and S-curve;
  - 5.8 Manpower schedule;
  - 5.9 PERT/CPM;
  - 5.10 Construction Safety and Health program;
  - 5.11 Financial Proposal;
  - 5.12 Photocopy of valid PhilGEPS Certificate; and
  - 5.13 Tax Clearance;

JHMC reserves the right to accept or reject any quotation, to annul the procurement process and reject all quotations at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders; to waive any minor defects or infirmities therein; and to accept such quotation as may be considered advantageous to the government.
