 - 5.1 Registration certificate from the Securities and Exchange Commission (SEC), Department of Trade and Industry (DTI) for sole proprietorship, or Cooperative Development Authority (CDA) for cooperatives;
 - 5.2 Mayor's Permit;





- 5.3 Valid Philippine Contractors Accreditation Board (PCAB) license and registration for the type and cost of the contract for the projects stated above;
- 5.4 List of all its ongoing and completed government and private contracts within ten (10) years from the submission of bids, including contracts awarded but not yet started, if any.
- 5.5 List of contractor's personnel (Project Manager, Project Engineer, and Foreman, Skilled Workers) to be assigned to the contract to be bid;
- 5.6 List of contractor's equipment units, which are owned, leased, and/or under purchase agreements, supported by certification of availability of equipment from the equipment lessor/vendor for the duration of the project;
- 5.7 Construction schedule and S-curve;
- 5.8 Manpower schedule;
- 5.9 PERT/CPM;
- 5.10 Construction Safety and Health program;
- 5.11 Financial Proposal;
- 5.12 Photocopy of valid PhilGEPS Certificate; and
- 5.13 Tax Clearance;
