
Bids received in excess of the ABC shall be automatically rejected. Submitted bids shall be considered independent of each other, therefore bidders may bid on any or all of the projects.

- 3. The quotation shall be quoted in Philippine Pesos, inclusive of all taxes to be paid if the contract is awarded.

- 5.4 List of all its ongoing and completed government and private contracts within ten (10) years from the submission of bids, including contracts awarded but not yet started, if any.
- 5.5 List of contractor's personnel (Project Manager, Project Engineer, and Foreman, Skilled Workers) to be assigned to the contract to be bid;
- 5.6 List of contractor's equipment units, which are owned, leased, and/or under purchase agreements, supported by certification of availability of equipment from the equipment lessor/vendor for the duration of the project;
- 5.7 Construction schedule and S-curve;
- 5.8 Manpower schedule;
- 5.9 PERT/CPM;
- 5.10 Construction Safety and Health program;
- 5.11 Financial Proposal;
- 5.12 Photocopy of valid PhilGEPS Certificate; and
- 5.13 Tax Clearance;
