### **DUTIES AND RESPONSIBILITIES:**

- 1. Prepare and develop a Program for Security and Safety, designed to complement and support the forest and environment management policies of JHMC.
- Coordinate the enforcement of environmental laws, rules and regulations with the Environment Management Department.
- 3. Conduct regular inspection of various areas within the reservation to ensure compliance with the adopted Program for Security and Safety.
- 4. Coordinate and monitor the implementation of the Fire Protection Program.
- 5. Direct and conduct Special Operations, Intelligence and Investigation.
- 6. Monitor and supervise the operations and activities of the private contracted security agency and ensure their compliance with the Contract for Security Services.
- 7. Establish and maintain network and inter-agency coordination with law enforcement, military units, and other security agencies to ensure their assistance is this should be necessary.
- 8. Design and implement plans for loss prevention and asset protection in accordance with the requirements of the organization.
- 9. Lead the organization in the development of the Crises Management Team and Emergency Response Plan respectively and ensure consistency thru the conduct of reviews, exercises and simulation drills.
- 10. Plan and execute all phases of VIP and event protection for company executives and activities.
- 11. Establish relationship with law-enforcement agencies, other government and private organizations to address security issues and concerns.
- 12. Manage the guard administration and operations and ensures interoperability with all units and assignments concerned.
- 13. Perform other functions that may be assigned from time to time.

- 3. Evaluates and recommends necessary policies, strategic measures on land management in order to preserve and protect the interest of JHMC and BCDA properties on issues related to land ownership, property turn-over and land development and management;
- 4. To oversee the allocation and utilization of BCDA's real estate;







- 5. Evaluate required land-based information and technical maps needed for planning of the development of Camp John Hay Reservation;
- 6. Reviews and is responsible for the processing, inspection and enforcement of the Geodetic Section of the Building Code;
- 7. Reports and updates the EAMD Manager regarding the divisions' objectives and targets; and
- 8. Perform other functions that may be assigned from time to time.
