

# TECHNICAL SPECIFICATIONS

## PROCUREMENT OF ONE (1) UNIT BRAND NEW MULTI – PURPOSE VEHICLE

This Technical Specification describes the description of one (1) unit Multi – Purpose Vehicle (MPV) to be procured for use of the John Hay Management Corporation (JHMC).

Budget Circular No. 2017-1 dated 26 April 2017, which was released by the Department of Budget and Management, amending Budget Circular (BC) No. 2016-05 entitled “*Revised Guidelines on the Acquisition and Use of Government Motor Vehicles*” dated 22 August 2016, states the definition of a **Multi-Purpose Vehicle**, to wit:

“a fully or partially enclosed four-wheel general purpose utility vehicle with two (2) compartments: (i) the front cabin/cab with two (2) side doors seating three (3) passengers, including the driver, on a full width seat, and (ii) the rear deck accommodating eight (8) to 16 passengers with facing collapsible bench seats accessible through rear door(s).”

### 1.0 BACKGROUND :

1.1 The Office of the President issued the Authority to Purchase to JHMC for one (1) unit brand new Multi – Purpose Vehicle.

#### 1.2 APPROVED BUDGET OF THE CONTRACT (ABC)

**Nine Hundred Thousand Pesos (PhP 900,000.00)**, inclusive of VAT and all other applicable government taxes, to be charged to the approved 2016 Corporate Operating Budget.

## **OTHER REQUIREMENTS**

### 1. Unit

- a. Must be at least ten (10) years in the Philippine Market.
- b. Availability of spare parts all over Luzon.
- c. Basic tool kit with complete set of tools, new spare tire, early warning device, tint, floor matting and rain visors.
- d. Free LTO registration for the first three (3) years.
- e. Free labor on preventive maintenance service within the first 5,000 kilometer check-up as the minimum.
- f. With air-conditioning unit.
- g. With magwheels.

### 2. Dealers

- a. Must be at least ten (10) years in the business as authorized dealer of brand new vehicles.
- b. Dealer must have service centers within Baguio City
