PROPOSED UNDERTAKING OF PARTIES:

- A. **ORGANIZER/COORDINATOR:** (John Hay Management Corporation)
 - 1. Payment of **Php 150,000.00** (inclusive of tax) for the reconstruction and reinstallation of the **PANAGBENGA HISTORICAL MARKER.**

B. ARTIST/SUPPLIER:

- 1. The Artist/Supplier shall be responsible for the reconstruction and reinstallation of Panagbenga Marker with the following specification:
 - The SUNFLOWER structure should be 10 feet by 10 feet in size
 - The overall structure should be 12 feet by 12 feet
 - Medium: RESIN and other necessary elements to the theme
 - Wooden base/stand
 - Wordings to be incorporated at surface/base:
 - "PANAGBENGA FLOWER FESTIVAL Since 1995"
 - Hardened, coated, and sealed
 - Paint specs as follows:
 - Sunflower with Lemon Yellow Petals
 - a. Forest Green Sepals and leaves
 - b. Light Brown to Dark Yellow Carpel
 - c. Forest Green Base/stand
- 2. An initial payment of 40% shall be paid to the Artist/Supplier prior to the reconstruction of the Panagbenga Marker and the 60% remaining balance shall be paid upon completion, delivery, and installation of the Panagbenga Marker.
- 3. Incidentals and other expenses not stipulated herein shall be under the account of the artist/supplier and must therefore be settled accordingly.

C. SANCTION/S (FOR BREACH)

Non-delivery or failure to comply on the above mentioned agreement would mean non-payment/cancellation of their contract with JHMC and would incur penalty for the damages. Should cancellation through no fault of Artist/Supplier occur less than TEN (10) days before the actual event, Artist/Supplier should provide a replacement artist/supplier of an equivalent or higher caliber for the same agreed package cost as the cancelled artist.

Failure to deliver the aforementioned commitment by the Artist shall incur penalty charges in favor of JHMC which is equivalent to 50% of the agreed package cost. Check should be payable to **John Hay Management Corporation.**

The date, time, and package cost as embodied in this agreement shall be strictly observed. Delay on the part of the artist in the delivery of the obligation incumbent upon him not exceeding TWO (2) days shall cause 25% penalty deductible from the package cost; THREE (3) days shall be penalized 50% of the package cost.

In cases of force Majeure, no show/non-performance caused by prohibition, war, blockage, revolution, insurrection, mobilization, strike, lockouts, civil commotion, riots, plague, or other epidemics, destruction of goods by fire or flood or any other cause or causes beyond control of both parties shall operate as cancellation of this contract.
