INVITATION TO BID

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The JHMC now invites bids for the Extension of Greenhouse Facility and Repair of Gardeners' Bunkhouse. Completion of the Works is required within Sixty-five (65) calendar days from issuance by JHMC of the Notice to Proceed (NTP) to the Contractor. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Error! Reference source not found.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
 - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

A complete set of Bidding Documents may be acquired by interested bidders from 31 May 2019 to 7 June 2019 from Cottage 624 Basement, JHMC Office Complex, JHSEZ, Camp John Hay, Baguio City upon payment of the applicable fee for the Bidding Documents as stated in Provision 1 above, pursuant to the latest Guidelines issued by the GPPB.
 - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 6. Bids must be duly received by the BAC Secretariat on or before **7 June 2019**, **9:00 A.M.** at the **Cottage 624 Basement**, **JHMC Office Complex**, **JHSEZ**, **Camp John Hay**, **Baguio City**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause **Error! Reference source not found.**
 - Bid opening shall be on **7 June 2019, 9:00 A.M.** at the Bell House, Camp John Hay, Baguio City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the above-stated address. Late bids shall not be accepted.
