## RE : AMENDMENT OF ANNEX C OF JHMC REORGANIZATION

This refers to the letter of PCEO Agbayani dated 13 December 2013<sup>1</sup> "request[ing] for some revisions to the GCG-Approved Staffing Pattern FY 2013 based on the discussions during the Technical Working Group meetings with the GCG-JHMC representatives."

The position titles as well as the job level in JHMC's approved staffing pattern under Annex C of GCG Memorandum Order No. 2013-45 are based on the existing titles of JHMC. The changes in the organizational structure as agreed upon during the TWG meetings were not incorporated in the staffing pattern. As represented, the proposed changes will not have an impact on the budgetary requirement of the JHMC Reorganization Plan since JHMC will continue to use its *existing* rates.
