PERFORMANCE AGREEMENT

This Performance Agreement has been executed pursuant to the **PERFORMANCE EVALUATION SYSTEM FOR THE GOCC SECTOR (GCG MC No. 2013-02 [Re-Issued])** between the –

GOVERNANCE COMMISSION FOR GOCCs (GCG)

- and -

JOHN HAY MANAGEMENT CORPORATION (JHMC)

WHEREAS, the Parties above entered into a Performance Agreement covering CY 2016;

WHEREAS, the Parties agreed to renegotiate certain targets for CY 2015, pursuant to Section 7.2 of GCG MC No. 2013-02 (Re-Issued), which provides that "GOCCs can renegotiate the targets set in their Performance Agreements for the current year if the same are no longer feasible <u>due to substantial changes in circumstances that could not have been foreseen at the time the targets were agreed upon.</u>"

WITNESSETH: THAT -

The Parties agree to the following terms:

- Renegotiation. JHMC's Performance Scorecard in its 2015 Performance Agreement is hereby amended pursuant to the attached Renegotiated Performance Scorecard. All other conditions in the Performance Agreement covering CY 2015 shall remain effective.
- 2. Mission and Vision. JHMC's Mission and Vision are as follows:
 - Mission: As the steward of Camp John Hay, John Hay Management Corporation develops the estate into a premier tourist and investment destination that enforces efficient and effective regulation, ensures sustainable multiple use of the forest watershed and contributes to national economic growth and job generation.
 - Vision : By 2018, the JHMC shall have transformed Camp John Hay into the primary catalyst for the tourism development within the Cordillera Region and the leader of environment and forest stewardship in the Philippines.

The agreed Strategy Map for achieving the vision is attached hereto as Annex A.

- Measurement of Performance. Performance for 2015-16 shall be measured based on the Performance Scorecard attached hereto as Annex B and Annex B-1, respectively. It is understood that the GOCC must achieve a weighted-average of at least 90% based on the agreed targets for 2015-16 to be eligible to grant any Performance-Based Bonus.
- **4. Strategic Initiatives.** JHMC hereby commits to undertaking the following key programs and/or projects identified as having a significant impact on its Performance Scorecard (PES Form 2) attached hereto as **Annex C**, to wit:



- (a) Strategic Initiative 1 Formulation of a Site Development Plan and Market Study for the Camp John Hay;
- (b) Strategic Initiative 2 Development of a Mixed Use Commercial Complex at Mile-Hi Center;
- (c) Strategic Initiative 3 Eco-Tourism Park Development;
- (d) Strategic Initiative 4 Increase Employment Inside the JHSEZ;
- (e) Strategic Initiative 5 Barangay Segregation Program;
- (f) Strategic Initiative 6 Formulation And Implementation Of An Integrated And Sustainable Pest Management Plan For The Benguet Pine Forests Of Camp John Hay;
- (g) Strategic Initiative 7 Support In The Preparation Of A Programmatic Environment Management Plan For New Development Projects;
- (h) Strategic Initiative 8 Ambient Air Emission And Greenhouse Gas Inventory Within The JHSEZ;
- (i) Strategic Initiative 9 Establishment of Firelines within the John Hay Reservation Area (JHRA);
- (j) Strategic Initiative 10 Compliance To Government Quality Management Systems Under Executive Order (E.O.) 605; and
- (k) Strategic Initiative 11 Organizational Learning And Growth Program To Arrive At The Overall Training Spread Index Target.

The Commitment herein includes obtaining all necessary approvals, if applicable, such as those for Major Development Projects under GCG MC No. 2013-03. JHMC shall include updates on the foregoing Strategic Initiatives in its submission of quarterly monitoring reports to the GCG.

- 5. Quarterly Submission of Performance Monitoring. JHMC shall submit a quarterly monitoring report to the GCG within thirty (30) calendar days from the close of each quarter.
- Good Governance Conditions. In addition to the covered portions of the Performance Scorecard, the GOCC must fully comply with the Good Governance Conditions enumerated under GCG MC No. 2013-02 (Re-Issued), GCG MC No. 2014-02, and GCG MC No. 2014-03 namely:
 - 6.1. Conditions Common to National Government Agencies and GOCCs:
 - (a) Transparency Seal;
 - (b) PhilGEPS Posting;
 - (c) Cash Advance Liquidation;
 - (d) Citizen's Charter or its equivalent; and
 - (e) Compliance with the submission and review requirements covering Statement of Assets, Liabilities and Networth (SALN);
 - 6.2. Conditions Specific to GOCCs Covered by R.A. No. 10149:
 - (a) Satisfaction of all statutory liabilities, including the payment of all taxes due to the Government, and declaration and payment of all dividends to the State as cleared by the Department of Finance (DOF), whenever applicable.

- (b) Submission and execution of concrete and time bound action plans for addressing Notices of Disallowances and Audit Observation Memoranda from the Commission on Audit (COA), if any.
- (c) Adoption of a "Manual of Corporate Governance" pursuant to Section 42 of the CODE OF CORPORATE GOVERNANCE FOR GOCCs (GCG MC No. 2012-07) that is approved by GCG and uploaded on the GOCC's website.
- (d) Compliance with posting on the GOCC's website the information enumerated under Section 43 of GCG MC No. 2012-07.
- (e) Adoption of a **NO GIFT POLICY** approved by the GCG and uploaded on the GOCC's website pursuant to Section 29 of GCG MC No. 2012-07.
- (f) Compliance with the deadlines and submission of reports through the Integrated Corporate Reporting System (ICRS) pursuant to GCG MC No. 2014-02.
- (g) Compliance by all members of the Governing Board with the submission of all required forms for the Director Performance Review (DPR) pursuant to GCG MC. No. 2014-03 and implementing issuances pursuant thereto.
- (h) Submission of Corporate Operating Budgets (COBs):
 - i. For GOCCs receiving national government budgetary support, COBs shall be submitted to the Department of Budget and Management (DBM) for review and approval on or before the deadline indicated in DBM National Budget Memorandum No. 123 on "Budget Call for FY 2016;"
 - For GOCCs without national government budgetary support, COBs shall be submitted to the Governance Commission using the same deadline as provided in DBM National Budget Memorandum No. 123.
- 7. JHMC shall timely inform GCG of all audit observations and notices of disallowances within seven (7) working days from the time it receives the same from the Commission on Audit (COA) prior to the regular publication of the final annual audit report. Accordingly, JHMC shall copy furnish the Governance Commission copies of all written communications between JHMC and COA on such matters, inform GCG of the schedule of its exit interview with COA seven (7) working days before the schedule or as soon as practicable, and other efficient means of inter-agency coordination.

Failure to timely disclose such matters to the Governance Commission prior to the same becoming public information or the submission of the application for the Performance-Based Bonus (PBB) or Performance-Based Incentive (PBI) may be considered as non-compliance with the Good Governance Condition of submitting Concrete and Time Bound Action Plans on findings of COA, rendering the Governing Board INELIGIBLE to apply for the PBI, without prejudice to a further determination on the impact of the same on the GOCCs PBB application.

8. Nothing herein shall be construed as limiting the authority of GCG to initiate renegotiations and/or revoke Performance Agreements in accordance with existing laws, rules and regulations.



3. Project Description:

Maintenance of good air quality is an indicator that the forest and watershed Reservation is being maintained and managed well. Improvement in air quality is attributed to the preservation of forested areas. Good air quality is not only achieved in Camp John Hay by the strict compliance of motor vehicles and other air pollution sources on emission standards but can very well be attributed to the sequestration of Carbon Dioxide and the filtering of particulate matters by the surrounding forest. This is because trees play a major role in intercepting and filtering particulate matter in the air.

With the National Ambient Air Quality Standards set forth in the Philippine Clean Air Act, Camp John Hay has the "GOOD" air quality index within the John Hay Special Economic Zone. It is then clear that Camp John Hay needs to maintain its "good" air quality index to be considered as a top

performer in comparison with other similar economically and commercially active areas within Baguio City and in the BLISTT.

The next milestone is to undertake an ambient air emission inventory which is the record that shows the amount of air pollutant discharged within a time period and location of the emission sources.

This will give a quantitative understanding of actual emissions from the JHSEZ and will guide JHMC in future projections and air pollution measure policies that may be set.

It is an indispensable tool widely used when formulating policies on anti-air pollution measures.

Emission Inventories are the basis for numerous efforts including trends analysis, regional, and local scale air quality modeling, regulatory impact assessments, and human exposure modeling. (EPA)
