**RECOMMENDING AWARD FOR THE PROCUREMENT OF SUPPLIES AND MATERIALS  
FOR THE ENHANCEMENT OF PICNIC TABLES AND PARKING SPACES WITHIN THE  
CAMP**

**WHEREAS**, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements with amounts of not more than Five Hundred Thousand Pesos (Php500,000.00);

**WHEREAS**, the BAC received Purchase Request (PR) No. 2025-197 from the Administrative Services Department-General Services Division (ASD-GSD) for the Procurement of Supplies and Materials for the Enhancement of Picnic Tables and Parking Spaces within the Camp. The Approved Budget for the Contract (ABC) for this procurement is **THREE HUNDRED THOUSAND PESOS (Php300,000.00)**. A copy of the said PR is attached as **Annex "A"**;

**WHEREAS**, in the approved Annual Procurement Plan (APP) for CY 2025, the procurement request falls under PAP Code No. GDS-201, with the mode of procurement as Small Value Procurement (SVP);

**WHEREAS**, the Request for Quotation (RFQ) was posted on the conspicuous place, PhilGEPs, and JHMC website. The RFQ was likewise distributed to suppliers of known qualifications, and in response thereto, JHMC received the following proposals:

NOW THEREFORE, THE MEMBERS OF THE BAC HEREBY RESOLVED TO RECOMMEND THE AWARD TO **MGM CONSUMER GOODS TRADING** FOR THE **PROCUREMENT OF SUPPLIES AND MATERIALS FOR THE ENHANCEMENT OF PICNIC TABLES AND PARKING SPACES WITHIN THE CAMP** IN THE TOTAL AMOUNT OF **TWO HUNDRED NINETY-NINE THOUSAND ONE HUNDRED TWENTY-FIVE PESOS (Php299,125.00)**.
