## **DUTIES AND RESPONSIBILITIES**

- 1. Assists in the preparation and/or implementation of Environment Management Division (EMD) Plans, Activities and Projects (PAPs) such as, but not limited to, the following:
  - a) Assists in the conduct of health assessment activities of Benguet Pine trees within the JHSEZ/JHRA;
  - b) Conducts tree inventory involving dead and/or pest-infested trees within JHSEZ/JHRA for tree cutting/pruning permit application with the DENR-CAR and/or Office of the City Mayor;
  - c) Assists in the quarterly monitoring of the health and physical status of trees within the JHSEZ/JHRA with the end in view of updating baseline Tree Inventory Reports;
  - d) Assists the Inspectorate Team in monitoring the implementation of issued Tree Cutting/Pruning/Earthblling Permit;
  - e) Assists DENR personnel in monitoring replacement planting activities and accomplishments and other forest plantation surveys;
  - f) Monitors retrieval cutting operations within the JHSEZ/JHRA;
  - g) Monitors nursery and ground maintenance activities, and recommends certain interventions for improvement, if any;
  - h) Assists in the preparation and implementation of enrichment planting activities including follow up operations as necessary;
  - i) Monitors the quarterly performance of Gardening and General Forest Care Service contracted personnel, and submits quarterly evaluation report;
  - j) Conducts site validation of violations against PD 705 as reported by SSD and submits reports to EMD for appropriate action;
  - k) Conduct analysis of monthly DENRO reports and submits recommendations to address issues and concerns, if any;
  - 1) Monitors the activities of students and other researchers within the JHSEZ/JHRA duly approved by the PCEO;
  - m) Assists in the identification of quality Pine trees for adoption under the Adopt-a-Tree-Project spearheaded by BDD;
  - n) Assists the EMD Manager, whenever necessary, in coordinating DENR, CEPMO and other government agencies in following up the status of EMD requests and other concerns with the said agencies with the end view of fast-tracking and eliciting positive actions on those requests and concerns.
- 2. Assists in the preparation and submission of required reportorial documents of EMD; and
- 3. Performs other activities as may be instructed by EMD from time to time as urgency demands.
