RE: AUTHORIZATION TO GRANT PBI TO JHMC BOARD OF DIRECTOR FOR FY 2013

Dear Chairperson Afable and PCEO Agbayani,

The JOHN HAY MANAGEMENT CORPORATION (JHMC) has satisfied the requirements of GCG MEMORANDUM CIRCULAR (MC) No. 2013-06 (RE-Issued) and the Checklist of Documents to be submitted by GOCCs to Qualify for the FY 2013 Performance-Based Incentive (PBI). This is based on:

- Certifications executed under oath by the Corporate Secretary;
- Review by the GCG of the completeness of required submissions from JHMC for FY 2013 PBI, including actual attendance rates (Annex A) and compliance with Good Governance Conditions specific to the GOCC Sector; and
- 3. Revised validation of the accomplishments of JHMC for FY 2013 with a final Performance Scorecard rating of 100% (Annex B), based on the supporting document that was provided to GCG for the evaluation of MFO 2, Quality 1 indicator (Compliance of JHMC to Environment and Forestry Standards, Laws, Rules and Regulations in the John Hay Special Economic Zone).

- The funding to support the PBI shall be charged by JHMC to its corporate funds, subject to Section 5, GCG MC No. 2013-06 (Re-Issued);
- The total cost of the PBI shall not result in a net loss for CY 2013 computed before subsidy and unrealized gains/losses, and after taxes; and
- In the event that the total amount of PBI to be distributed exceeds
 the Corporate Operating Budget (COB) level, the Governing Board
 shall request from DBM the approval of the Supplemental Budget
 necessary for this purpose.

This is a one-time approval applicable only for FY 2013.
