<p><b>Organizational Objectives and Principles</b></p> <p>The organization has a solid track record in terms of incorporating environmental goals and objectives in its programs and projects</p>	15 points
<p><b>Campaigns and Actions</b></p> <p>Initiates activities and campaigns to protect and manage the pollution releases of the locator</p>	15 points
<p><b>Result or Concrete Achievements</b></p> <p>Attained concrete victories, helped communities through projects or campaigns, and enabled the organization to build its capacity and unity towards environment protection</p>	20 points
