REQUEST FOR EXPRESSION OF INTEREST

RELOCATION SURVEY / RE-ESTABLISHMENT AND MONUMENTING OF THE CORNERS OF OPEN SPACES, FOREST AREAS, AND COMMUNITY FACILITIES WITHIN SCOUT BARRIO CAMP JOHN HAY, BAGUIO CITY

- 1. JOHN HAY MANAGEMENT CORPORATION (JHMC), through the *COB 2023* intends to apply the sum of **Nine Hundred Sixty Thousand Pesos and 0/100** (*PHP 960,000.00*) being the Approved Budget for the Contract (ABC) to payments under the contract for **Consulting Services for the Relocation Survey** / **Re-Establishment and Monumenting of the Corners of Open Spaces, Forest Areas, and Community Facilities within Scout Barrio Camp John Hay, Baguio City.** Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
- 2. JHMC now calls for the submission of eligibility documents for Consulting Services for the Relocation Survey / Re-Establishment and Monumenting of the Corners of Open Spaces, Forest Areas, and Community Facilities within Scout Barrio Camp John Hay, Baguio City. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before 20 September 2023, 9:30 AM at the JHMC Office Building, Camp John Hay, Baguio City. The preferred submission shall be through electronic or manual means and strictly not a combination of both.

For manual submission, prospective bidders must submit one (1) original and two (2) copies of eligibility documents at the **JHMC Office Building, Camp John Hay, Baguio City.** Lacking or additional documents not included in the sealed envelopes shall not be accepted.

Submission of eligibility documents may be done through electronic means, provided that:

- a. The file must be password protected to ensure the security, integrity, and confidentiality of the eligibility documents;
- b. The passwords for accessing the file will be disclosed by the Bidders only during the actual bid opening which may be done in person or face-to-face through videoconferencing, webcasting, or similar technology; and
- c. The complete documents shall be emailed to bac@jhmc.com.ph

Refer to Section 26 of RA 9184 and its IRR for modification or withdrawal of eligibility documents.

Late submissions shall not be accepted.

- 3. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion in accordance with Section II of Bidding Documents.
- 4. The bidding consultant must have the following minimum qualifications:

The consultant must be in the business of providing Land Surveying services for at least three (3) years. In the case of joint ventures, each company should have at least three (3) years of business operation;

It may also be downloaded free of charge from the Philippine Government Electronic Procurement System (PhilGEPS) website and www.jhmc.com.ph provided that Bidders shall pay the applicable fee for the Bidding Documents not later than submitting their bids.

- 7. The BAC shall draw up a short list of consultants from those who have submitted Expressions of Interest and/or Eligibility Documents and have been determined as eligible in accordance with the provisions of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act," and its Implementing Rules and Regulations (IRR).
- 8. The shortlist may preferably consist of **five (5) prospective bidders** who will be entitled to submit bids. The criteria and rating system for shortlisting are:

In the case of a **sole prospective bidder**, the same shall undergo an eligibility check and shortlisting process pursuant to Section 36 of the 2016 Revised IRR of RA 9184.







- 9. The JHMC shall evaluate bids using the Quality-Cost Based Evaluation/Selection (QCBE/QCBS) procedure. The weights to be allocated for the Technical will be 80% and Financial Proposals 20%. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
- 10. Bidding will be conducted through open competitive bidding using a non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184 bidding and is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
 - Prospective Bidders who opt for video conferencing must inform the BAC Secretariat of their intent through the electronic mail address listed below. The Pre-Bid Conference is open to prospective bidders, but attendance is not mandatory.
- 11. JHMC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders.
