RECOMMENDING AWARD FOR THE PROCUREMENT OF CATERING SERVICES DURING MEETINGS FOR THE BARANGAY SEGREGATION PROGRAM

WHEREAS, it is the task of the Bids and Awards Committee (BAC) to recommend to the Head of Procuring Entity (HOPE), and to ensure that the JHMC abides by the standards set forth by Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" and its 2016 Revised Implementing Rules and Regulations, to all its procurement activities;

WHEREAS, the BAC received Purchase Request (PR) No. 2024-040 from the Environment and Asset Management Department – Land and Asset Management Division (EAMD-LAMD) for the procurement of catering services during meetings for the Barangay Segregation Program. The Approved Budget for the Contract (ABC) for this procurement is Seven Hundred Nine Thousand Nine Hundred Fifty Pesos (PhP709,950.00). A copy of the said request is hereto attached as *Annex "A"*;

WHEREAS, in the approved JHMC Annual Procurement Plan (APP) for FY 2024, the purchase request falls under PAP Code of GDS-108 with the mode of procurement as Small Value Procurement (SVP);

WHEREAS, the Request for Quotation (RFQ) was posted on the PhilGEPs and JHMC website. The RFQ was likewise distributed to suppliers/providers of known qualifications, and in response thereto, JHMC received the following proposals which were duly evaluated by the BAC;
