WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements through alternative modes with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00):

WHEREAS, the BAC received Purchase Request (PR) No. 2024-085 from the Administrative Services Department – Human Resource Division (ASD-HRD) for the procurement of materials, catering, and other services for the conduct of Safety and Security Related Knowledge for ERT, Safety and Health Committee.
