RESOLUTION NO. 2024-066

RECOMMENDING AWARD FOR THE PROCUREMENT OF LEASE OF VENUE INCLUDING MEALS AND OTHER MATERIALS FOR THE JHMC'S OPERATIONS PLANNING FOR CY 2025

WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements through alternative modes with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00);

WHEREAS, the BAC received Purchase Request (PR) No. 2024-078 from the Office of the President and Chief Executive Officer - Corporate Planning Unit (OPCEO-CPU) for the procurement of Lease of Venue Including Meals and Other Materials for the JHMC's Operations Planning for CY 2025. The Approved Budget for the Contract (ABC) for this procurement is One Hundred Twenty Thousand Pesos (PhP120,000.00). A copy of the said request is attached as *Annex "A"*;

WHEREAS, in the approved Annual Procurement Plan (APP) for FY 2024, the procurement request falls under PAP Code of GDS-134 with mode of procurement as Lease of Real Property and Venue (LRPV);

WHEREAS, the Request of Quotation (RFQ) was posted in the PhilGEPs and JHMC website. The RFQ was likewise distributed to lessors of known qualifications, and in response thereto, JHMC received the following proposals which were duly evaluated by the BAC:

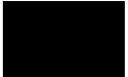

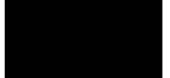
