## RESOLUTION NO. 2024-076

## RECOMMENDING AWARD FOR THE PROCUREMENT OF CATERING SERVICES DURING DENRO TRAINING AND COMPETENCY DEVELOPMENT PROGRAM

WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements through alternative modes with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00);

WHEREAS, the BAC received Purchase Request (PR) No. 2024-071 from the Environment and Asset Management Department – Environment Management Division (EAMD-EMD) for the procurement of Catering Services during DENRO Training and Competency Development Program.
