RECOMMENDING AWARD FOR THE PROCUREMENT OF AGROFORESTRY MATERIALS AND SUPPLIES

WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements through alternative modes with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00);

WHEREAS, the BAC received Purchase Request (PR) No. 2024-066 from the Environment and Asset Management Department – Environment Management Division (EAMD-EMD) for the procurement of Agroforestry Materials and Supplies. The Approved Budget for the Contract (ABC) for this procurement is One Hundred Twenty-Six Thousand Two Hundred Fifty Pesos (PhP126,250.00). A copy of the said request is attached as *Annex "A"*;

WHEREAS, in the approved Annual Procurement Plan (APP) for FY 2024, the procurement request falls under PAP Code of GDS-034 for the Agroforestry Materials and Supplies with the mode of procurement as Small Value Procurement (SVP);

WHEREAS, the Request for Quotation (RFQ) was posted on the PhilGEPs and JHMC website. The RFQ was likewise distributed to suppliers of known qualifications, and in response thereto, JHMC received only one (1) proposal:
