RECOMMENDING AWARD FOR THE PROCUREMENT OF ANTI-VIRUS SOFTWARE

WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements through alternative modes with amounts of not more than Five Hundred Thousand Pesos (Php500,000.00);

WHEREAS, the BAC received Purchase Request (PR) No. 2024-155 from the Administrative Services Department– Information and Communication Technology Division (ASD-ICTD) for the procurement of anti-virus software. WHEREAS, in the approved Annual Procurement Plan (APP) for CY 2024, the procurement request falls under PAP Code No. GDS-029 with the mode of procurement as Small Value Procurement (SVP);
