RECOMMENDING AWARD FOR THE PROCUREMENT OF SEMI-EXPANDABLE EQUIPMENT, FURNITURE AND FIXTURES, MATERIALS FOR BCDA COTTAGE USE

WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements through alternative modes with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00);


