WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements through alternative modes with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00);

WHEREAS, the BAC received Purchase Request (PR) No. 2024-235 from the Office of the President and Chief Executive Officer – Community Relation Office (OPCEO-CRO) for the Procurement of Supplies for the Kalusugan Project 2024.
