RECOMMENDING AWARD FOR THE PROCUREMENT OF REPAIR AND MAINTENANCE OF HISTORICAL CORE AREAS AND CCA OFFICE-REFURBISH THE TOTEM POLE IN THE HISTORICAL CORE

WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements through alternative modes with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00);

WHEREAS, the BAC received Purchase Request (PR) No. 2024-260 from the Administrative Services Department-General Services Division (ASD-GSD) for the Procurement of Repairs and maintenance of Historical Core Areas and CCA office - Refurbish the Totem Pole in the Historical Core. The Approved Budget for the Contract (ABC) for this procurement is **ONE** HUNDRED THOUSAND PESOS (Php100,000.00). A copy of the said PR is attached as Annex "A";

WHEREAS, in the approved Annual Procurement Plan (APP) for CY 2024, the procurement request falls under PAP Code No. GDS-090 with the mode of procurement as Small Value Procurement (SVP);

WHEREAS, the Request for Quotation (RFQ) was posted on the conspicuous place, PhilGEPs, and JHMC website. The RFQ was likewise distributed to suppliers of known qualifications, and in response thereto, JHMC received the following proposals:


