

CONTRACT AGREEMENT
(Consulting Services for Water Surveys within Camp John Hay)


THIS AGREEMENT made this _____ between **JOHN HAY MANAGEMENT CORPORATION**, with office address at John Hay Special Economic Zone, Camp John Hay, Baguio City (hereinafter called "**JHMC**") of the one part and **GEOMASTER CORPORATION**, with office address at U-15A Upper G/F Diliman Commercial Center Commonwealth Avenue, Batasan Hills, Quezon City, (hereinafter called the "**Consultant**") of the other part;

WHEREAS, **JHMC** is desirous that the **Consultant** execute the contract agreement for the Consulting Services for Water Surveys within Camp John Hay (hereinafter called "**the Works**") and **JHMC** has accepted the bid for **Six Hundred Forty Five Thousand Pesos (PhP645,000.00)** by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, viz.:
 - i. Request for Expression of Interest;
 - ii. Terms of Reference;
 - iii. Winning bidder's bid, including the Eligibility requirements, and all other documents or statements submitted.
3. In consideration of the payments to be made by the **JHMC** to the **Consultant** as hereinafter mentioned, the **Consultant** hereby covenants with **JHMC** to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this **Consultant** in all respects.
4. **JHMC** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
