

CONTRACT AGREEMENT
(Solid Waste Management for VOA, BCDA Cottages, Historical Core Area,
JHMC Offices, Customs Clearance Area)

THIS AGREEMENT made this DEC 11 2024 between **JOHN HAY MANAGEMENT CORPORATION**, with office address at John Hay Special Economic Zone, Baguio City, Benguet, Philippines (hereinafter called "**JHMC**") of the one part and **MR. BASILIO S. ANIS, JR.**, doing business under the name and style of **MCBEANS JUNKSHOP**, with office address at A-29 Poblacion, La Trinidad, Benguet (hereinafter called "**SERVICE PROVIDER**") of the other part;

WHEREAS, **JHMC** invited Bids for services, particularly procurement of Solid Waste Collection Services for VOA, BCDA Cottages, Historical Core Area, JHMC Offices, Customs Clearance Area, and has accepted a Bid by the **SERVICE PROVIDER** for the supply of the services in the sum of **Three Hundred Fifty-One Thousand Six Hundred Pesos (PhP351,600.00)** (hereinafter called "**the Contract Price**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz. :
 - i. Request for Quotation
 - ii. Scope of Services;
 - iii. Winning bidder's bid, including the Eligibility requirements, and all other documents or statements submitted.
3. In consideration for the sum of **Three Hundred Fifty-One Thousand Six Hundred Pesos (PhP351,600.00)** or such other sums as may be ascertained, **SERVICE PROVIDER** agrees to deliver the services in accordance with its Bid.
4. **JHMC** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

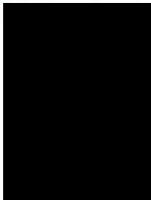
