RECOMMENDING AWARD FOR THE PROCUREMENT OF CATERING SERVICES FOR THE CONDUCT OF LOCATORS MEETING INCLUDING ORIENTATIONS AND SPOT INSPECTIONS


WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements through alternative modes with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00);

WHEREAS, the BAC received Purchase Request (PR) No. 2025-006 from the Special Economic Zone Administration Department (SEZAD) for the Procurement of Catering Services for the Conduct of Locators' Meetings including Orientations and Spot Inspections. The Approved Budget for the Contract (ABC) for this procurement is **THREE HUNDRED FIFTY THOUSAND PESOS (PhP350,000.00)**. A copy of the said PR is attached as *Annex "A"*;

WHEREAS, in the approved Annual Procurement Plan (APP) for CY 2025, the procurement request falls under PAP Code No. GDS-145 with the mode of procurement as Small Value Procurement (SVP);

WHEREAS, the Request for Quotation (RFQ) was posted on the conspicuous place, PhilGEPs, and JHMC website. The RFQ was likewise distributed to suppliers of known qualifications, and in response thereto, JHMC received the following proposals:
