RESOLUTION NO. 2025-023

RECOMMENDING AWARD FOR THE PROCUREMENT OF RETRO LAMP WOODEN CHANDELIER CEILING LAMP

WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements through alternative modes with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00);

WHEREAS, the BAC received Purchase Request (PR) No. 2025-031 from the Administrative Services Department- General Services Division (ASD-GSD) for the Retro Lamp Wooden Chandelier Ceiling Lamp. The Approved Budget for the Contract (ABC) for this procurement is **SEVENTY THOUSAND PESOS (PhP 70,000.00)**. A copy of the said PR is attached as *Annex "A."*;

WHEREAS, in the approved Annual Procurement Plan (APP) for CY 2025, the procurement request falls under PAP Code No. GDS-009, with the mode of procurement as Shopping 52.1 (b);

WHEREAS, the Request for Quotation (RFQ) was posted on the conspicuous place, PhilGEPs, and JHMC website. The RFQ was likewise distributed to suppliers of known qualifications, and in response thereto, JHMC received the following proposals:
