RECOMMENDING AWARD FOR THE PROCUREMENT OF CATERING SERVICES DURING MEETINGS FOR CAMP JOHN HAY COMMUNITY REDEVELOPMENT PROJECT

WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements through alternative modes with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00);


WHEREAS, the BAC received Purchase Request (PR) No. 2025-013 from the Environment and Asset Management Department – Land and Asset Management Division (EAMD-LAMD) for the Catering Services during meetings for Camp John Hay Community Redevelopment Project. The Approved Budget for the Contract (ABC) for this procurement is **FOUR HUNDRED NINETY-NINE THOUSAND NINE HUNDRED PESOS (PhP 499,900.00)**. A copy of the said PR is attached as *Annex "A."*;

WHEREAS, in the approved Annual Procurement Plan (APP) for CY 2025, the procurement request falls under PAP Code No. GDS-106, with the mode of procurement as Small Value Procurement (SVP);

WHEREAS, the Request for Quotation (RFQ) was posted on the PhilGEPs and JHMC website. The RFQ was likewise distributed to suppliers of known qualifications, and in response thereto, JHMC received the following proposals which were duly evaluated by the BAC;
