GENERAL DUTIES AND RESPONSIBILITIES

2. Provide inputs towards the formulation of water and wastewater management programs based on strategic and socially sound, inclusive and gender-responsive measures.
3. Perform the following activities in relation to implementation of the above:
 - 3.1. Monitor commitments and agreements entered into by JHMC on water and wastewater management.
 - 3.2. Review and validate the status of sanitation – related projects, including non infra projects of JHMC.
 - 3.3. Provide technical assistance to JHSEZ locators to comply with wastewater and water management concerns in relation to sanitation including non-infra project, as requested by the Office of the Building Official.
4. Conduct spot – checking, audits and inspections on the sanitation projects/s being implemented when necessary.
5. Provide inputs in the review of technical assessment tools, modules, manuals and guidebooks for sanitation facilities such as STPs, waste facilities, and the like.
