RECOMMENDING AWARD FOR THE PROCUREMENT OF LAUNDRY SERVICES


WHEREAS, it is the task of the Bids and Awards Committee (BAC) to recommend and to ensure that the JHMC abides by the standards set forth by Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" and its Revised Implementing Rules and Regulations (RIRR), to all its procurement activities;

WHEREAS, the BAC received Purchase Request (PR) No. 2025-024 from the Administrative Services Department-General Services Division (ASD-GSD) for the Procurement of Laundry Services. The Approved Budget for the Contract (ABC) for this procurement is **EIGHT HUNDRED THOUSAND PESOS (Php 800,000.00)**. A copy of the said PR is attached as *Annex "A."*;

WHEREAS, in the approved Annual Procurement Plan (APP) for CY 2025, the procurement request falls under PAP Code No. GDS-065, with the mode of procurement as Small Value Procurement (SVP);

WHEREAS, the Request for Quotation (RFQ) was posted on the conspicuous place, PhilGEPs, and JHMC website. The RFQ was likewise distributed to suppliers of known qualifications, and in response thereto, JHMC received the following proposals:
