- 9. Reviewed and recommended the JHMC Corporate Operating Budget for CY 2025 to the Board for approval.
- 10. Reviewed JHMC's regulatory fees, penalties and charges and endorsed them to the Board for approval.
- 11. Evaluated and endorsed the request for authority to approve and sign disbursements of funds.
