RECOMMENDING AWARD FOR THE PROCUREMENT OF GARDENING AND FOREST CARE SUPPLIES AND MATERIALS

WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00);

WHEREAS, the BAC received Purchase Request (PR) No. 2025-084 from the Environment and Asset Management Department – Environment Management Division (EAMD-EMD) for the Procurement of Gardening and Forest Care Supplies and Materials. The Approved Budget for the Contract (ABC) for this procurement is **TWO HUNDRED THIRTY-NINE THOUSAND TWO HUNDRED PESOS (Php 239,200.00)**. A copy of the said PR is attached as *Annex "A."*;

WHEREAS, in the approved Annual Procurement Plan (APP) for CY 2025, the procurement request falls under PAP Code No. GDS-056, with the mode of procurement as Small Value Procurement (SVP);

WHEREAS, the Request for Quotation (RFQ) was posted on the conspicuous place, PhilGEPs, and JHMC website. The RFQ was likewise distributed to suppliers of known qualifications, and in response thereto, JHMC received the following proposals:
