**RECOMMENDING AWARD FOR THE PROCUREMENT OF LED WALL, INCLUDING
INSTALLATION AND OTHER SERVICES**

WHEREAS, it is the task of the Bids and Awards Committee (BAC) to ensure that the John Hay Management Corporation (JHMC) abides by the standards set forth by Republic Act No. 12009, otherwise known as "The New Government Procurement Act" and its Implementing Rules and Regulations (IRR), in all its procurement activities;

WHEREAS, the BAC received Purchase Request (PR) No. 2025-183 from the Business Development Department (BDD) for the Procurement of Led wall, including installation and other services. The Approved Budget for the Contract (ABC) for this procurement is **Two Million Seven Hundred Pesos (PhP2,700,000.00)**. A copy of the said request is attached as **Annex "A"**;

WHEREAS, in the approved Annual Procurement Plan (APP) for CY 2025, the procurement request falls under PAP Code of GDS – 208 for the Procurement of Led wall, including installation and other services with the mode of procurement as Competitive Bidding;

WHEREAS, in the opening of bids conducted on 15 October 2025, the results are as follows:

WHEREAS, the BAC declared **BLOOMSOCIAL, INC.** as technically and financially eligible, subject to the detailed evaluation by the End-User and the Technical Working Group (TWG). A copy of the Abstract of Bids is attached hereto as *Annex "B"*;

WHEREAS, the End-user and the TWG conducted a bid evaluation. As a result of the bid evaluation, the BAC declared **BLOOMSOCIAL, INC.** as the bidder having the Lowest Calculated Bid (LCB) and shall undergo the Post-Qualification process. A copy of the Bid Evaluation Report of the End-user and the TWG is attached as *Annex "C"*;

WHEREAS, with the overall result of the post-qualification conducted on 23 October 2025, the BAC declared **BLOOMSOCIAL, INC.** as the bidder having the Lowest Calculated and Responsive Bid (LCRB). A copy of the Post-Qualification Report of the End-user and the TWG is attached as *Annex "D"*;

NOW THEREFORE, THE MEMBERS OF THE BAC HEREBY RESOLVED TO RECOMMEND THE AWARD TO **BLOOMSOCIAL, INC.** FOR THE **PROCUREMENT OF LED WALL, INCLUDING INSTALLATION AND OTHER SERVICES** IN THE TOTAL AMOUNT **ONE MILLION THREE HUNDRED TEN THOUSAND PESOS (PHP 1,310,000.00)**.
