

RESOLUTION NO.: **2025-157**DATE: **02 October 2025****RECOMMENDING AWARD FOR THE PROCUREMENT OF SUPPLIES FOR THE 2025  
CORPORATE GIVEAWAYS**

**WHEREAS**, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00);

**WHEREAS**, the BAC received Purchase Request (PR) No. 2025-166 from the Office of the President and CEO- Community Relations Office (OPCEO-CRO) for the Procurement of Supplies for the 2025 Corporate Giveaways. The Approved Budget for the Contract (ABC) for this procurement is **FOUR HUNDRED THOUSAND PESOS (PhP400,000.00)**. A copy of the said PR is attached as **Annex "A."**;

**WHEREAS**, in the approved Annual Procurement Plan (APP) for CY 2025, the procurement request falls under PAP Code No. GDS-103, with the mode of procurement as Small Value Procurement (SVP);

**WHEREAS**, the Request for Quotation (RFQ) was distributed to three (3) prospective suppliers of known qualifications, and in response thereto, JHMC received the following proposals, which the BAC duly evaluated:
