

RESOLUTION NO.: **2025-171**DATE: **22 October 2025****RECOMMENDING AWARD FOR THE PROCUREMENT OF PLAYGROUND EQUIPMENT
FOR THE SCOUT HILL PARK, INCLUDING INSTALLATION AND OTHER SERVICES**

WHEREAS, it is the task of the Bids and Awards Committee (BAC) to ensure that the John Hay Management Corporation (JHMC) abides by the standards set forth by Republic Act No. 12009, otherwise known as "The New Government Procurement Act" and its Implementing Rules and Regulations (IRR), in all its procurement activities;


WHEREAS, the BAC received Purchase Request (PR) No. 2025-185 from the Business Development Department (BDD) for the Procurement of Playground Equipment for the Scout Hill Park, including installation and other services. The Approved Budget for the Contract (ABC) for this procurement is **Three Million Pesos (PhP3,000,000.00)**. A copy of the said request is attached as **Annex "A"**;

WHEREAS, in the approved Annual Procurement Plan (APP) for CY 2025, the procurement request falls under PAP Code of GDS – 207 for the Procurement of Playground Equipment for the Scout Hill Park, including installation and other services with the mode of procurement as Competitive Bidding;

WHEREAS, in the opening of bids conducted on 15 October 2025, the results are as follows:

WHEREAS, the BAC declared **EXPRESS WASTE SOLUTIONS, INC.** as technically and financially eligible, subject to the detailed evaluation by the End-User and the Technical Working Group (TWG). A copy of the Abstract of Bids is attached hereto as **Annex "B"**;

WHEREAS, the End-user and the TWG conducted a bid evaluation. As a result of the bid evaluation, the BAC declared **ONE GLOBAL DEVELOPMENT, INC.** as the bidder having the Single Calculated Bid (SCB) and shall undergo the Post-Qualification process. A copy of the Bid Evaluation Report of the End-user and the TWG is attached as Annex "C";

WHEREAS, with the overall result of the post-qualification conducted on 22 October 2025, the BAC declared **ONE GLOBAL DEVELOPMENT, INC.** as the bidder having the Single Calculated and Responsive Bid (SCRB). A copy of the Post-Qualification Report of the End-user and the TWG is attached as Annex "D";

NOW THEREFORE, THE MEMBERS OF THE BAC HEREBY RESOLVED TO RECOMMEND THE AWARD TO **ONE GLOBAL DEVELOPMENT, INC.** FOR THE **PROCUREMENT OF PLAYGROUND EQUIPMENT FOR THE SCOUT HILL PARK, INCLUDING INSTALLATION AND OTHER SERVICES** IN THE TOTAL AMOUNT OF **TWO MILLION NINE HUNDRED THOUSAND AND EIGHTY PESOS (PHP2,900,080.00)**
