RECOMMENDING AWARD FOR THE PROCUREMENT OF SOLID WASTE MANAGEMENT SERVICES FOR CAMP JOHN HAY

WHEREAS, it is the task of the Bids and Awards Committee (BAC) to ensure that the John Hay Management Corporation (JHMC) abides by the standards set forth by Republic Act No. 12009, otherwise known as "The New Government Procurement Act" and its Implementing Rules and Regulations (IRR), in all its procurement activities;

WHEREAS, the BAC received Purchase Request (PR) No. 2025-107 from the Administrative Services Department - General Services Division (ASD-GSD) for the Procurement of Solid Waste Management Services for Camp John Hay. The Approved Budget for the Contract (ABC) for this procurement is **Nine Million Five Hundred Thousand Pesos (PhP9,500,000.00)**. A copy of the said request is attached as **Annex "A"**;

WHEREAS, in the approved Annual Procurement Plan (APP) for CY 2025, the procurement request falls under PAP Code of GDS – 193 for the Procurement of Solid Waste Management Services for Camp John Hay with the mode of procurement as Competitive Bidding;

WHEREAS, in the opening of bids conducted on 8 October 2025, the results are as follows:

WHEREAS, the BAC declared **EXPRESS WASTE SOLUTIONS, INC.** as technically and financially eligible, subject to the detailed evaluation by the End-User and the Technical Working Group (TWG). A copy of the Abstract of Bids is attached hereto as **Annex "B"**;

WHEREAS, the End-user and the TWG conducted a bid evaluation. As a result of the bid evaluation, the BAC declared **EXPRESS WASTE SOLUTIONS, INC.** as the bidder having the Single Calculated Bid (SCB) and shall undergo the Post-Qualification process. A copy of the Bid Evaluation Report of the End-user and the TWG is attached as Annex "C";

WHEREAS, with the overall result of the post-qualification conducted on 16 October 2025, the BAC declared **EXPRESS WASTE SOLUTIONS, INC.** as the bidder having the Single Calculated and Responsive Bid (SCRB). A copy of the Post-Qualification Report of the End-user and the TWG is attached as Annex "D";

NOW THEREFORE, THE MEMBERS OF THE BAC HEREBY RESOLVED TO RECOMMEND THE AWARD TO **EXPRESS WASTE SOLUTIONS, INC.** FOR THE **PROCUREMENT OF SOLID WASTE MANAGEMENT SERVICES FOR CAMP JOHN HAY** IN THE TOTAL AMOUNT OF **NINE MILLION FOUR HUNDRED NINETY NINE THOUSAND EIGHT HUNDRED FIFTY NINE PESOS & 91/100 (PhP9,499,859.91)**.
