- JHMC agrees to pay the above-mentioned sum to the SUPPLIER in accordance with the schedule and manner provided in the Bidding Documents and its annexes.
- 5. Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).
- 6. To ensure continuing compliance with tax laws pursuant to Executive Order No. 398;
 - The SUPPLIER shall pay taxes in full and on time, failure to do so will entitle JHMC to suspend payment.
 - The **SUPPLIER** is likewise required to submit, prior to the execution the Agreement, a tax clearance from the Bureau of Internal Revenue (BIR) as well as a copy of her income and business tax
