

## CONTRACT FOR THE CONSTRUCTION OF TWO (2) RESTROOMS AT THE SCOUT HILL

This **CONTRACT** executed on the \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_\_, by and between:

**JOHN HAY MANAGEMENT CORPORATION**, a government-owned and controlled corporation, operating by virtue of the laws of the Republic of the Philippines, with office address at the John Hay Special Economic Zone, Camp John Hay, Loakan Road, Baguio City, hereinafter called "**JHMC**";

-and-

**LOG-AKA CONSTRUCTION**, a company duly organized and existing under the laws of the Republic of the Philippines, with principal office at Bila, Bauko, Mountain Province, hereinafter called "**CONTRACTOR**";

**WHEREAS**, **JHMC** invited Bids for certain goods and works, particularly the procurement of an infrastructure project known as the Construction of Two (2) Restrooms at the Scout Hill;

**WHEREAS**, the **CONTRACTOR** submitted a responsive bid and was awarded the contract for the procurement in the total amount of **One Million Nine Hundred Ninety Four Thousand Nine Hundred Fifty Nine Pesos and 21/100 (PhP1,994,959.21)**, hereinafter referred to as the "**Contract Price**".

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the parties hereby agree as follows:

1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.
2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009 shall form part and be read and construed as integral parts of this Contract, viz:

    - i. Drawings/Plans;
    - ii. Scope of Work;

    - v. Bid Data Sheet;
    - vi. Bid Form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including

- vii. Bill of Quantities;
- viii. General and Special Conditions of Contract;
- ix. Supplemental Bid Bulletins, if any; and
- x. Other contract documents that may be required by existing laws and/or **JHMC**.

b. Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;

c. Performance Security;

d. Notice of Award of Contract; and the Bidder's Conforme thereto; and

e. Other contract documents that may be required by existing laws and/or **JHMC**, such as but not limited to the Notice to Proceed and Warranty Security.

3. In consideration of the Contract Price of **One Million Nine Hundred Ninety Four Thousand Nine Hundred Fifty Nine Pesos and 21/100 (PhP1,994,959.21)**, or such other sums as may be determined in accordance with the terms of the Contract, the **CONTRACTOR** agrees to deliver and perform the items and related services for the Construction of Two (2) Restrooms at the Scout Hill described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.

4. **JHMC** agrees to pay the above-mentioned sum to the **CONTRACTOR** in accordance with the schedule and manner provided in the Bidding Documents and its annexes.

5. Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).

6. To ensure continuing compliance with tax laws pursuant to Executive Order No. 398;

a. The **CONTRACTOR** shall pay taxes in full and on time, failure to do so will entitle **JHMC** to suspend payment.

b. The **CONTRACTOR** is likewise required to submit, prior to the execution the Agreement, a tax clearance from the Bureau of
