JOHN HAY MANAGEMENT CORPORATION, a government-owned and controlled corporation, operating by virtue of the laws of the Republic of the Philippines, with office address at the John Hay Special Economic Zone, Camp John Hay, Loakan Road, Baguio City, hereinafter called "**JHMC**";

-and-

ONEGLOBAL DEVELOPMENT INC., a company duly organized and existing under the laws of the Republic of the Philippines, with principal office at 6527 C. Lawis Ext., Brgy. San Luis, Antipolo City, Rizal, hereinafter called "**SUPPLIER**";

WHEREAS, JHMC invited Bids for certain goods and services, particularly procurement of Playground Equipment for the Scout Hill Park, including installation and other services;

WHEREAS, the **SUPPLIER** submitted a responsive bid and was awarded the contract for the procurement in the total amount of **Two Million Nine Hundred Thousand Eighty Pesos (Php2,900,080.00)**, hereinafter referred to as the "**Contract Price**".

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.

In consideration of the Contract Price of **Two Million Nine Hundred Thousand Eighty Pesos (Php2,900,080.00)**, or such other sums as may be determined in accordance with the terms of the Contract, the **SUPPLIER** agrees to deliver and perform the items and related services for the Playground Equipment for the Scout Hill Park, including installation and other services described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.

- 4. **JHMC** agrees to pay the above-mentioned sum to the **SUPPLIER** in accordance with the schedule and manner provided in the Bidding Documents and its annexes.

- 5. Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).

- 6. To ensure continuing compliance with tax laws pursuant to Executive Order No. 398;

- a. The **SUPPLIER** shall pay taxes in full and on time, failure to do so will entitle **JHMC** to suspend payment.

- b. The **SUPPLIER** is likewise required to submit, prior to the execution the Agreement, a tax clearance from the Bureau of Internal Revenue (BIR) as well as a copy of her income and business tax
