**RECOMMENDING AWARD FOR THE PROCUREMENT OF PROCUREMENT OF ELEVEN
(11) MOVABLE/ MODULAR HOUSES**

WHEREAS, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements with amounts of not more than Five Hundred Thousand Pesos (Php500,000.00);

WHEREAS, the BAC received Purchase Request (PR) No. 2025-195 from the Administrative Services Department – General Services Division (ASD-GSD) for the Procurement of Procurement of Eleven (11) Movable/ Modular Houses. The Approved Budget for the Contract (ABC) for this procurement is **Five Hundred Fifty Thousand Pesos (Php550,000.00)**. A copy of the said request is attached as **Annex "A"**;

WHEREAS, in the approved Annual Procurement Plan (APP) for CY 2025, the procurement request falls under PAP Code of GDS-197 for the Eleven (11 Movable/ Modular Houses) with the mode of procurement as Small Value Procurement (SVP);
