**RECOMMENDING AWARD FOR THE PROCUREMENT OF LANDSCAPING SERVICES FOR THE ENHANCEMENT OF POCKET GARDENS IN CJH**

WHEREAS, it is the task of the Bids and Awards Committee (BAC) to ensure that the John Hay Management Corporation (JHMC) abides by the standards set forth by Republic Act No. 12009, otherwise known as "The New Government Procurement Act" and its Implementing Rules and Regulations (IRR), in all its procurement activities;

**WHEREAS**, the BAC received Purchase Request (PR) No. 2025-181 from the Environment and Asset Management Department – Environmental Management Division (EAMD-EMD) for the Procurement of Landscaping Services for the Enhancement of Pocket Gardens in CJH. The Approved Budget for the Contract (ABC) for this procurement is **Nine Hundred Fifty Thousand Pesos (PhP950,000.00)**. A copy of the said request is attached as **Annex "A"**;
