**RECOMMENDING AWARD FOR THE PROCUREMENT OF CONFERENCE AND TRAINING  
ROOMS EQUIPMENT AND SERVICES**

**WHEREAS**, pursuant to Board Resolution No. 2024-0115-007, the President and CEO was delegated the authority to approve BAC Resolutions recommending award on behalf of the Head of Procuring Entity (HoPE) for procurements with amounts of not more than Five Hundred Thousand Pesos (PhP500,000.00);

**WHEREAS**, the BAC received Purchase Request (PR) No. 2025-232 from the Administrative Services Department- Information and Communications Technology Division (ASD-ICTD) for the Procurement of Conference and Training Rooms Equipment and Services. The Approved Budget for the Contract (ABC) for this procurement is **ONE MILLION EIGHT HUNDRED THOUSAND PESOS (PhP1,800,000.00)**. A copy of the said request is attached as **Annex "A"**;

**WHEREAS**, in the approved Annual Procurement Plan (APP) for CY 2025, the procurement request falls under PAP Code No. GDS-217, with the mode of procurement as Small Value Procurement (SVP);

**WHEREAS**, the Request for Quotation (RFQ) was posted on the conspicuous place, PhilGEPs, and JHMC website. The RFQ was likewise distributed to suppliers of known qualifications, and in response thereto, JHMC received the following proposals:
